**PLAINTIFFS’ MOTION FOR AWARD OF ATTORNEYS’ FEES, COSTS
AND EXPENSES AND FOR CLASS REPRESENTATIVE SERVICE AWARDS**

Plaintiffs Sarah Kent and Alison Pactong (“Plaintiffs”), by and through their undersigned counsel, respectfully move this Court, pursuant to Practice Book Section 9-9, for an order: (a) awarding Plaintiffs’ counsel attorneys’ fees in the amount of \$950,000, representing one-third of the Settlement Fund; (b) awarding Plaintiffs’ counsel \$3,441.84 in unreimbursed litigation costs and expenses incurred in the prosecution of this Action; and (c) authorizing a service award of \$10,000 to each of the Class Representatives, Sarah Kent and Alison Pactong.

This matter comes to be heard on the Motion for Award of Attorneys’ Fees, Cost and Expenses and for Class Representative Service Awards (the “Motion”) filed by Plaintiffs Sarah Kent and Alison Pactong, individually and on behalf of the Settlement Class (as defined below), by and through Jonathan M. Shapiro of Aeton Law Partners LLP and Jonathan M. Jagher or Freed Kanner London & Millen, LLC.

Having reviewed and considered the Motion and supporting memorandum and affidavit, and having heard and considered the arguments of counsel, the Court makes the finding and grants the relief set forth below.

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. Plaintiffs’ counsel is hereby awarded attorneys’ fees in the amount of \$950,000, which the Court finds to be fair and reasonable.

2. Plaintiffs' counsel is hereby awarded \$3,441.84 for reimbursement of expenses, which the Court finds to be reasonably incurred and necessary to the successful prosecution of this Action.

3. Class Representatives Sarah Kent and Alison Pactong are each hereby awarded \$10,000 as service awards in recognition of the time and effort they contributed to the successful prosecution of this Action.
